## FAQ:

### Will the revision classes be F2F?

All revision classes are planned to be F2F except as indicated. Due to various SOP like “restriction on operating hours - no classes are allowed at campus after 6pm, maximum class size, capacity constraints”, we are unable to run 100% F2F for all revision classes. Therefore, some subjects are having partial F2F and some are fully virtual live/online. While all care has been exercised in planning the revision timetable, the college reserves all rights to switch the F2F class to Online-Mode should unforeseen circumstances occur.

### What should I prepare?

#### For F2F class

1. You have to complete our DECLARATION FORM before you enter the college premise.
2. You are required to be equipped with Face-Mask.
3. If you failed temperature check, you will not be permitted to join the F2F class.
4. Revision notes are distributed during the first day of the class, in the classroom.
5. A class-allocation schedule will be sent to you prior to your revision class – to indicate your classroom.

#### For Virtual class

1. You will need to have a laptop or desktop to zoom in. You may install the Zoom app in your computer by visiting [zoom.us](https://zoom.us) to register for a free account.
2. We will create a WHATSAPP group for the subject you have enrolled, at least 3days before the first class.
3. We will inform you how to collect your revision notes.

### Any text book or practice kit being included?

We only provide revision course notes for revision students. There will be no text book, practice kit or normal class notes to be given out.

### How to register?

1. Fill in our registration form. (last page)
2. Provide us a copy of your ACCA status report.
3. Provide us a copy of your Identification Card.

5. We shall confirm your registration and advise you on the payment details. You can pay by cash/cheque/e-wallet (Boost)
6. All registration must be completed at least 5-day before the commencement of the first class.
